**Item No.8.3**

The Member-Secretary, Principal Dr. Santosh V. Koti brought to the notice of all the members that as per the recommendations of BoEE in its communication with ref.no. WCS/Exam 2025-26/24 dated 28-07-2025 re-examination for the non-eligible students of B.A. First Year from NEP-24 pattern for the academic year 2025-26 was organized from 04-08-2025 to 12-08-2025. He further informed that 130 students registered and appeared for the examination. 81 students passed the examination whereas 42 students secured ATKT and final passing percentage was 94.62%. Shriman B. V. Shah appreciated the entire team for its efforts.
